## TERMS AND CONDITIONS

The Turlock Irrigation District (TID) Residential Charger Rebate Program is intended to encourage the purchase and use of Qualifying Electric Vehicles within the boundaries of the TID.

The Program may be modified, amended or terminated without prior notice, at the sole discretion of TID.

The applicant must be an active customer of record (Customer) of the TID, and must remain so throughout the entire rebate process.

The rebate is limited to the cost of the charging equipment (not including installation or labor).

The Qualified Electric Vehicle Supply Equipment (Charger) must:

- a. Be New (not refurbished) and Level 2 Charger;
- b. Be certified by Underwriters Laboratories Inc. (UL Listed);
- c. Be mounted and installed at the address in the application;

**The Qualifying Electric Vehicle (Qualifying EV) must:**

- a. Be purchased at a retail automobile sales company. Private party sales, transfer between parties, gifts, prizes or any other method of owning a vehicle other than purchase from retail automobile sales company do not qualify for the program.
- b. Be registered with the California Department of Motor Vehicle (DMV) at the address of customer within the TID electric service territory.
- c. Be able to charge via plugging into a electrical outlet.
- d. Be a plug-in electric vehicle at date of purchase or lease;
- e. Not be a motorcycle or scooter.

TID is offering a rebate of \$300 toward the purchase of a new level 2 electric vehicle charger installed at your home. Customers enrolled in the CARES program are eligible for an additional \$100 per charger.

To apply, fill out a Residential Charger Rebate Form and provide copies of the following:

- **Proof of purchase for a Level 2 Electric Vehicle Charger. The cost of the charger must be shown separate from the cost of installation.**
- **Current DMV registration for the qualifying electric vehicle.**

Completed applications are accepted on a first-come, first served basis and are processed in the order received until funds are exhausted or the Program is terminated. The acceptance of an application by TID is not a guarantee of rebate funds.

Rebates cannot be assigned or transferred.

Completed applications must be received by TID no later than six (6) months from the purchase date of the charger in order to be eligible for the program.

Applications that are not complete, without a signature, or without all required documents will neither be processed nor entitle the applicant to be included in the first-come, first-served funding order of the rebate.

A maximum of two (2) Program rebates are allowed per household.

Customer must make the Charger available for inspection by a TID employee upon request.

Rebate eligibility is determined at the time of application, based on the information received.

TID is not responsible for any items delayed or lost in the mail.

TID disclaims any and all liability for loss or damage which may arise as a result of the Customer's participation in this rebate program.
